In addition, the court ***calls upon*** the organization to submit, in accordance with Section h) of Paragraph Art. 91. (1) of Law CLXXI of 2011, its official contact data ('Company Gate' registration data) as regulated by the Act on Electronic Administration and the General Rules of Confidentiality Services.

The present ruling cannot be contested.

Due to the nature of the present decree or the proceedings on the basis of which it has been issued - or in case the documents enclosed with the application are not compliant with the law - the prosecutor and those whom the present ruling affect, can file a lawsuit against the organization regarding the contents of the ruling that affect them, in order to initiate the revocation of the ruling by the court that is competent at the organization's registered place of business. The lawsuit can be initiated within sixty days of the publication of this order in the National Registry. Failure to comply with the deadline entails loss of this right.

R a t i o n a l e

In their submission to the court the applicant requested the amendment of the foundation's registration data in line with recent changes.

The court has established that the requested amendments and the documents submitted comply with the legal requirements in all respects. Hence, the court ruled in accordance with the related provisions in the enacting clause of Art. 30. (1), referred to by Art. 37. (1) of Act CLXXXI of 2011 on the Court Registration of Civil Society Organisations and Related Rules of Proceeding.
